

Healthy Food for All Eligibility

Guidelines

The Healthy Food for All (HFA) program is open to everyone in the community. You do not need to be a member of Wild Oats to be eligible.

To qualify, you must participate in one of the following programs:

EBT

Medicaid

WIC

Massachusetts Residents: Mass Health—We accept the Standard, Basic, Essentials, Senior Buy-in and Buy-in programs

New York Residents: Child Health Plus, Family Health Plus

Vermont Residents: Green Mountain Care—We accept the Catamount Health, Dr. Dynasaur and Vermont Health Access Plan programs

The program offers a 10% dis-

count on store purchases, ex-

cluding consignment items and

special orders, to people who

qualify for other forms of low

income assistance (see back of

brochure for eligibility guide-

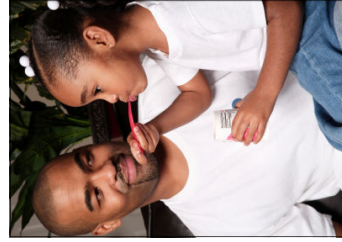
lines). HFA discounts cannot be

combined with other store dis-

counts. You do not need to be a

Wild Oats member to be eligible

for this program.



How to Sign Up

It's easy! Just fill out the attached application and return it in person to Wild Oats. To qualify for the program, you must show personal identification and printed proof of participation in one other low income assistance program when you submit your application. Proof of participation can be in the form of an up-to-date EBT card or a certification letter from the other program you participate in. See other side of brochure for a list of qualifying programs.

Once approved, you will be eligible for the program discount through May of the following year. To continue as a participant after that date, you will



need to reapply. You must submit an application to participate in the program, even if you are currently participating in our Low Income Assistance (LIA) program. We've made the application process as quick and easy as possible.

HFA Application

Please bring your completed form, personal ID and printed proof of participation in a qualifying program to any cashier. You will be given a one-time 10 percent discount, excluding consignment and special orders, to use while your application is being processed. Once approved, you will be notified by phone. Please allow 72 hours for approval. Membership must be renewed yearly in May. It is the participant's responsibility to reapply each year.
